

Introduction

As part of the Love Your Lake Shoreline Assessment program, a values survey was conducted to gauge the opinions of residents on Wakaw Lake about major concerns and important qualities of Wakaw Lake. This report summarizes the preliminary results of the survey which was distributed to the 901 shoreline property owners on residents on Wakaw Lake, 116 of whom provided their responses. The results of each survey were compiled in an excel file which were then analyzed by Watersheds Canada and the Canadian Wildlife Federation in the form of tables and histograms. Conclusions were made based on trends among the responses, and identification of potential stewardship initiatives to help the Carrot River Valley Watershed Association focus their stewardship efforts.

Results

Property Ownership



Of the 116 respondents to the values survey, 97 (84%) identified themselves as seasonal residents, and 19 (16%) identified themselves as permanent residents, as shown below.

Time spent on Wakaw Lake varied from 3 years to as many as 75 years, lake with 28 years as the average number of years spent on the lake.

Recreation

The top three recreational activities identified by the 116 survey respondents included fishing, swimming, and power boating.

In order of popularity from most to least popular, the number and percentage of shoreline property owners on Wakaw Lake that participate in recreational activities are summarized in Table 1 below.

Values Associated with Personal Enjoyment




Figure 1. Distribution of Wakaw Lake shoreline property owner responses regarding elements affecting enjoyment of the lake.

The most important elements of Wakaw Lake, valued for their impact on personal enjoyment of the lake, included water quality, scenery/view, and tranquility/quiet. Figure 1 shows the distribution of ranked values for each element, in order of the most valuable to least valuable element. Surveys asked respondents to rate each activity from 1 to 5 with 5 being very important and 1 being not important.

Top Issues Facing Wakaw Lake




Figure 2. Distribution of shoreline property owner responses identifying the top issues faced by Wakaw Lake.

The most frequently identified issue facing Wakaw Lake provided by the 116 respondents was water quality, followed by water levels, and shoreline development. Table 2 below summarizes the number and percentage of respondents that identified each issue as a top concern. Figure 2 shows the distribution of shoreline property owner responses regarding the top issues facing Wakaw Lake.

Actions to Undertake to benefit Wakaw Lake and Community

The most frequently identified actions shoreline property owners on Wakaw Lake believe would benefit the lake and community include:

- Undertake more water quality testing
- Limit boat wakes near shore
- Create rules for new development

Perceived Water Quality Concerns

Of the 116 survey respondents, 48 (41%) perceive water quality to be good, 59 (51%) perceive water quality to be poor, 8 (7%) don't know about the water quality, and 1 (1%) perceive water quality to be excellent.




Figure 3. Ranking of top water quality concerns.

The top concerns expressed about water quality were algae/aquatic vegetation, some other concerns such as chemical contamination, and smell. Table 4 summarizes the number and percentage of responses identifying each water quality concern for Wakaw Lake. Figure 3 shows the distribution of shoreline property owner responses regarding water quality concerns on Wakaw Lake.

Shoreline Property Owner Interest in Stewardship Information and Activities

Of the 116 respondents, 89 (77%) said they were interested to learn more about their activities and how it affects water quality, wildlife habitat, and the overall health of the lake. When asked whether they would be interested in participating in stewardship activities around the lake, 43 respondents (37%) answered "yes".

Discussion

On the completed surveys, water quality was the single most important factor affecting the property owners' enjoyment of the lake with 92 respondents rating it as a "very important" factor. As well, 86% of respondents placed water quality as one of their top concerns regarding the health of Wakaw Lake.

When shoreline property owners were asked to identify the top actions that would benefit their lake, undertake more water quality testing was the most recommended followed by limit boat wakes near shore, and create rules for new development. The Carrot River Valley Watershed Association may consider gathering more information on this as well as getting opinions from more residents on Wakaw Lake.

Residents rate fishing as the top activity on Wakaw Lake with 83% saying they participated in this lake activity. This result provides an opportunity to the Carrot River Valley Watershed Association for more stewardship initiatives by showing that the suitability of the environment for recreational activities could be jeopardized if current issues are not addressed.

When asked about the overall water quality, residents seem to be conflicted. 51% seem to think that Wakaw Lake has poor water quality and 41% think that the lake has good water quality.

Conclusion

The main concern seems to be water quality among lake residents. Other main concerns were water levels, shoreline development, and faulty or poorly maintained septics.

On Wakaw Lake 77% of respondents are willing to learn more about how to help the health of the lake. There appears to be opportunity for planning and stewardship programs to help restore and preserve Wakaw Lake. By engaging with all interest groups and landowners in a coordinated effort, the protection of Wakaw Lake can be improved.
